



TERMS AND CONDITIONS FOR ZERO SPREAD CAMPAIGN

Titan FX, operated by Titan FX Limited, Titan Markets and Atlantic Markets Limited, may offer, from time to time, at its sole and absolute discretion, Zero Spread Campaign (the “Campaign”) to its clients.

These terms form an integral part of [Titan FX’s Terms and Conditions](#). By participating in the Campaign, clients acknowledge and agree to be bound by these terms and by [Titan FX’s Terms and Conditions](#).

1. Campaign Overview & Eligibility

- 1.1. The Campaign offers eligible clients the opportunity to trade selected FX pairs with zero spreads during the Campaign Period, subject to these Terms.
- 1.2. The Campaign Period will run from 29th June 2026 00:00 GMT +3 until 19th July 2026 23:59 GMT +3.
- 1.3. The Campaign Period consists of:
 - 1.3.1. Week1: June 29th 00:00, 2026 to July 5th 23:59, 2026 GMT +3)
 - 1.3.2. Week2: July 6th 00:00, 2026 to July 12th 23:59, 2026 (GMT +3)
 - 1.3.3. Week3: July 13th 00:00, 2026 to July 19th 23:59, 2026 (GMT +3)
- 1.4. Zero spreads will not apply between 22:00 GMT+3 and 02:00 GMT+3 each day.
- 1.5. The Campaign is available to existing and newly approved clients holding Standard or Blade accounts.
- 1.6. Micro accounts are not eligible. Zero spread conditions apply to eligible Blade Accounts only. Standard Accounts are subject to a fixed spread of 1 pip on the selected FX pairs during the Campaign Period.



- 1.7. Details of the selected FX pairs covered by the Campaign are available <https://titanfx.com/promotions/zero-spreads> and may be amended at Titan FX's discretion.
- 1.8. Unless otherwise specified, this Campaign may be combined with other Titan FX promotions, offers or promo codes.

2. Fraudulent Activity

- 2.1. Titan FX may, at its sole discretion, exclude a client from participating in the Campaign, if the client:
 - 2.1.1. has engaged in fraudulent, abusive or dishonest conduct;
 - 2.1.2. has not acted in good faith;
 - 2.1.3. is found to be in violation of these terms or Titan FX's Terms and Conditions; or
 - 2.1.4. has submitted false, misleading or inaccurate information during account registration or verification process.
- 2.2. Clients found to be abusing negative balance protection, engaging in abusive trading behaviour, or suspected of such abuse may be disqualified from the Campaign at Titan FX's sole discretion, without prior notice or explanation.

3. General Legal Conditions

- 3.1. In participating in the Campaign, the client agrees to be bound by these terms and Titan FX's Terms and Conditions.
- 3.2. The client agrees that Titan FX has the right to alter, update or cancel the Campaign at any time without any prior notice or justification to the client.



- 3.3. While Titan FX intends to offer zero spreads during the Campaign Period, zero spreads are not guaranteed and may not be available at all times.
- 3.4. Titan FX reserves the right to apply, modify, widen, or remove spreads at its sole discretion, including but not limited to circumstances involving abnormal market conditions, natural disasters, central bank interventions, low liquidity, system issues, force majeure events, or any other circumstances beyond Titan FX's reasonable control.
- 3.5. The client agrees that Titan FX will not be held responsible for any losses, cost, expense, damage, or missed opportunity arising from any alteration, update or cancellation of the Campaign.
- 3.6. The client agrees that Titan FX shall not be held responsible for any technical disruption, such as weak internet connection, outside its reasonable control that could affect the result of the Campaign.
- 3.7. Titan FX reserves the right to refuse participation in the Campaign at its sole discretion without prior notification or justification.
- 3.8. Titan FX shall not be liable for any losses, costs, expenses or adverse effects arising from the modification, suspension or removal of the Campaign while a client has open positions or floating profit/loss.
- 3.9. New accounts are subject to approval as per Titan FX's Terms and Conditions. The Campaign is not an offer to any person to whom it would not be lawful.
- 3.10. The Campaign shall not encourage clients to trade in a manner inconsistent with their trading comfort level. Clients should seek independent advice if necessary.



- 3.11. By participating in the Campaign, clients consent to their personal data being collected, processed, and used by Titan FX for marketing and promotional purposes.
- 3.12. Titan FX will not be liable for any loss, costs, expense or damage suffered in connection with the Campaign.
- 3.13. Any dispute arising in connection with the Campaign shall be resolved by Titan FX in a fair and reasonable manner.
- 3.14. If these terms are translated in another language other than English, the English version of these terms is the official version and shall prevail in case of inconsistency.
