

SPECIFIC PROMOTION TERMS AND CONDITIONS

FOR CRYPTO PARADISE QUEST PROMOTION

The Crypto Paradise Quest Promotion (the **Promotion**) is provided by Titan FX Limited, trading under Titan FX, to its clients. By participating in this Promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by <u>Titan FX</u> <u>Limited's Terms and Conditions</u> (**Titan FX**).

Promotion overview

This Promotion offers eligible clients the chance to win prizes during the Promotion period from September 18th 00:01 GMT+3 to October 15th 23:55 GMT+3.

1. Specific Offer terms

- 1.1. The client must register for the Promotion in their Client Cabinet and select their main Promotion account.
- 1.2. A client has to net deposit at least 35,700 JPY / 250 USD / 230 EUR / 380
 AUD / 335 SGD and trade at least 25,000 USD trade value in cryptocurrency instruments to participate in the Promotion.
- 1.3. Net deposit requirements:
 - 1.3.1. The client's net deposits are a sum of all deposits minus all withdrawals in all their accounts between registering for the Promotion and the end of the Promotion period.
 - 1.3.2. Net deposits are calculated in the currency of the client's chosen main Promotion account. If the client makes deposits or withdrawals into/from other accounts that have a different account



currency, the current exchange rate is used to convert the deposit or withdrawal into the Promotion account currency.

- 1.3.3. Withdrawals of only trading profit earned from trades that were opened after the client registered for the Promotion and closed before the end of the Promotion will not be subtracted from the net deposits.
- 1.3.4. If the client withdraws more than their trading profit or a portion or all of their deposited amount at any time during the Promotion window, this may decrease their net deposit amount which may result in the participant being ineligible to participate further in the lottery.
- 1.4. Trade value requirements:
 - 1.4.1.1. Trade value is the total notional trade value of all the trades in any of the client's accounts, opened after the client registered for the Promotion.
 - 1.4.1.2. Cryptocurrency instruments, including those traded in micro accounts, are eligible and count towards the total trade value.
 - 1.4.1.3. Trade value is recorded at the time that the trade is opened.

1.5 During the Promotion, Titan FX guarantees fixed spreads listed and traded BTCUSD, BTCJPY, ETHUSD, ETHJPY, BTCUSD-m instruments.

2. Trade and account eligibility

2.1. The client has to have a registered and verified account.



- 2.2. This Promotion is applicable to all cryptocurrency instruments tradeable in all live Titan FX accounts.
- 2.3. Both new and existing clients are eligible to participate.
- 2.4. Only trades that have been opened in the Promotion window are eligible trades.

3. Prize Terms

3.1. Clients are eligible to win the prizes outlined below:

- 3.3. The client will be informed about winning within 3 working days after the winner announcement via the client's provided email.



- 3.4. The cash prize (if selected) is presented as a transfer into the client's Titan FX trading account that they selected as their main promotion account when registering. If their main promotion account is not a USD or JPY account, the current exchange rate is used to convert the cash prize amount into the Promotion account currency.
- 3.5. It is the client's responsibility to ensure that accurate contact details are provided. If Titan FX is unable to contact the client due to inaccurate contact details provided, and the client does not contact Titan FX within 30 days to claim their prize, the client's prize will be voided without any liability on Titan FX.
- 3.6. The prize cannot be exchanged. In the event that the prize offered is unavailable due to circumstances beyond the control of Titan FX, Titan FX reserves the right to provide an alternative prize.
- 3.7. Titan FX does not provide invoices and warranty certificates for electronics.
- 3.8. If the client receives a damaged or broken prize, the client must send a photo or video to the customer support of Titan FX. If the damage is confirmed, Titan FX will replace the prize.
- 3.9. Images used in marketing materials and on the website of Titan FX are for illustration purposes only and are not representative of actual prizes.

4. Delivery terms

- 4.1. Delivery may not be available in the client's country. Titan FX can decide, at its own discretion, to send a cash prize to the client instead.
- 4.2. The client must choose an address of delivery for the prize. The address must be on the name of the client.



- 4.3. It is the client's responsibility to ensure that an accurate delivery address is provided. The client cannot change the delivery address once the prize has been claimed.
- 4.4. The prize is handed to the client at the address of delivery by courier. If the client is absent for delivery, the courier will handle the re-delivery. The client shall contact the courier to ensure delivery.

5. Fraudulent activity

- 5.1. Titan FX at its sole discretion can exclude a client from participating in this Promotion:
 - 5.1.1. if a client is suspected of fraudulent activity; and/or
 - 5.1.2. and/or a client has not acted in good faith; and/or
 - 5.1.3. and/or an action by a client is found to be in violation of these terms or Titan FX's Terms and Conditions ; and/or
 - 5.1.4. if a client submits false ID documents and phone number for the verification procedure.

6. General conditions and warranties

- 6.1. In participating in this Promotion, you agree to be bound by these terms and Titan FX's Terms and Conditions.
- 6.2. You agree that Titan FX has the right to alter, update or cancel this Promotion at any time without any prior notice or justification to you.
- 6.3. You agree that Titan FX will not be held responsible for any consequences resulting from any alteration, update or cancellation of this Promotion.
- 6.4. Titan FX reserves the right to refuse offering this Promotion at its sole discretion without prior notification or justification.



- 6.5. Titan FX will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.
- 6.6. New accounts are subject to approval as per Titan FX's Terms and Conditions. This Promotion is not an offer to any person to whom it would not be lawful.
- 6.7. This Promotion shall not encourage clients to trade in a manner inconsistent with their trading comfort level. Clients should seek independent advice if necessary.
- 6.8. By participating in this Promotion, you consent to your personal data being collected, processed, and used by Titan FX for:
- 6.9. Titan FX will not be liable for any loss, costs, expense or damage suffered in connection with this Promotion.
- 6.10. Any dispute will be resolved by Titan FX in a fair manner.
- 6.11. If these terms are translated in another language other than English, the English version of these terms is the official version and shall prevail in case of inconsistency.
